VERILY TESTING

A FREE drive-up coronavirus testing program launched in Mono County on June 2. This is the latest testing site launching as part of the California state government's community-based COVID-19 testing program with support from Project Baseline. Check if you're eligible and to schedule an appointment for FREE testing using the Baseline COVID-19 Program online at <u>Screener and Appointment Scheduling System.</u>

The next availability for testing through this program will be in Bridgeport on <u>June 5 between 10am and</u> 1pm. As always, if you feel sick, you can always call 2-1-1 to speak to a nurse right away.

Every business permitted to reopen in Mono County and in the Town of Mammoth Lakes is required to self-report on meeting all applicable County, State and Federal requirements using the <u>SELF-CERTIFICATION PORTAL</u>. Businesses that satisfy all the health and safety requirements, are required to prominently post the certificate at their place of business. We also recommend you review the Frequently Asked Questions document for your business sector/activity and follow the recommendations detailed in the Mono County Business Guidelines.

Widespread adoption of such measures and recommendations will build customer confidence and promote Mono County as a safe place to live and visit. As the situation evolves, the guidelines will be updated to reflect new information.
